Payment, Refund, and Group Responsibility Policies To protect the integrity of our reservations system and in fairness to others whose camping plans rely upon it, we adopted the following payment, refund, and group responsibility policies:									
Deposit To confirm your reservations, a non-refundable deposit of 25% of estimated charges is required. Payment Terms									

A statement will be sent the week after your event for the final balance due within 30 days. Your group will be charged for "no-shows" and people who cancel after you have provided numbers the week before your scheduled event.

Discounts are applied to housing charges only. Groups of 30 or more are entitled to a 10% discount. Evangelical Lutheran Church of America (ELCA) congregations and organizations receive an additional 10% discount. Children 4 through 10 years receive a 50% discount on food service. Children 3 and younger stay and eat free.

Final Group Size

Our staff will contact you two weeks before your event. The final group size must be submitted one week prior to arrival.

Insurance Policy

The Group agrees to provide at two weeks prior to arrival, a certificate of insurance naming TX-LA Gulf Coast Synod Outdoor Ministries, Inc. dba Lutherhill Ministries as an additional insured for the entire period of the reservation at \$1 million per occurrence. Failure to provide insurance will result in cancellation of the reservation and forfeiture of deposit. If unable to provide, please contact Lutherhill Ministries for options.

Cancellation Policy

Cancellations received 30 days or more before arrival date can apply their deposit to a rescheduled event within 12 months. Cancellations received 29 days or less before their arrival date will be billed for 50% of the estimated charges less deposit.

Responsibility Policy

It is the responsibility of the Group Contact Person to collect the names, addresses, emergency contact name and number, and health/allergy information for all group members. Additionally, a permission to treat must be collected for all persons under 18 years of age. Additionally, groups are responsible for determining the need and completion of background checks of their leaders and training leaders for one-on-one camper situations.

Guest Policies

Please review the Guest Policies provided to the group leader and available on our website. You are expected to ensure your group abides by them. Lutherhill Ministries will provide an on-site emergency contact that will also be available for emergency transportation.

In signing this contract you and your group agrees that Lutherhill Ministries shall not be liable to the rental group for any damages from any cause to its members or to property owned by the group. To the fullest extent permitted by the law, the rental group shall hold harmless Lutherhill Ministries and its representatives, agents, and employees from and against all liabilities, claims, damages, losses, expenses, and other costs, including but not limited to costs of attorney's fee arising out of, or resulting from, or in connection with the use of the Camp by the rental group, its members, agents, employees, invitees, licenses, guest, or representatives. Return a signed copy of this agreement, along with your deposit to Lutherhill Ministries. An estimated invoice of charges is available on request.

The undersigned agrees to provide supervision to assure all participants abide by all rules and procedures of Lutherhill Ministries.
